Saint Mary-of-the-Woods College status changed from "Accredited" to "Accredited On Notice"

Effective: June 26, 2025

The Higher Learning Commission (HLC) has placed Saint Mary-of-the-Woods College in St. Mary of the Woods, Indiana, on Notice. HLC took this action because it determined that the institution is at risk of being out of compliance with HLC's Criteria for Accreditation.

Notice is a public sanction that allows the institution a period of time to resolve the areas of concern. The initial period for Notice is up to two years. While on Notice, the institution remains accredited.

What This Means for Students

In most cases, other colleges and universities will continue to accept the institution's credits in transfer or for admission to a higher degree program. All colleges and universities define their own transfer and admission policies. Students interested in pursuing a higher degree or transferring should contact the college or university they plan to attend so that they are knowledgeable about the admission and transfer policies for that college or university.

Noted HLC Requirements

HLC concluded the institution is at risk of being out compliance with the Criteria for Accreditation, and needs to address concerns related to the following Criteria:

- Criterion 2, Core Component 2.A, "Integrity"
- Criterion 2, Core Component 2.C, "Sufficient Board autonomy"
- Criterion 5, Core Component 5.A, "Effective governance and administrative structures"
- Criterion 5, Core Component 5.B, "Resource base"

HLC also concluded the institution does not meet, and will need to address concerns related to the following Assumed Practice:

Assumed Practice D.4, "Effective governance and administrative structures"

Next Steps

The institution will host an embedded Notice visit in fall 2026 as part of its comprehensive evaluation for reaffirmation of accreditation in order to provide evidence that it is no longer at risk of being out of compliance with the Criteria for Accreditation and Assumed Practices.

At the end of the Notice period, HLC may remove the institution from Notice if it has demonstrated that it is no longer at risk of being out of compliance with the Criteria. If the institution is still at risk of being out of compliance with the Criteria — or if the institution is out of compliance with the Criteria — HLC may take another action in accordance with HLC policies, including extending Notice, placing the institution on Probation, issuing a Show-Cause Order or withdrawing accreditation.
